Vote regarding the Center for Advanced Technology and Communication in Health (CATCH)

The approval of the FSC, subject to the approval of the Board of Trustees of CUNY, approves the creation of a Center for Advanced Technology and Communication in Health, to be housed at the CUNY Graduate School of Public Health and Health Policy (CUNY SPH), effective December 14, 2020. This Center is projected to be financed by over four million dollars in extramural research and contracts, alongside modest contributions from the School.

Explanation: The mission of the Center for Advanced Technology and Communication in Health at the CUNY Graduate School of Public Health and Health Policy is to develop and implement new technologies and approaches to help decision making in the health and public health arena.

Motion to Vote on Governance Plan:

A poll on one of the two following options concerning the composition of the Schoolwide APT Committee:

Option 1:

The Committee shall be comprised of ten members: the Dean or their designee (non-voting); the Chairpersons of the four departments; four other faculty members, one from each department elected by the voting faculty members of the respective department; and one atlarge faculty member elected by the voting faculty members of the Council. Upon the affirmative vote of three faculty Committee members, the Committee may meet in executive session without the non-voting member present.

Option 2:

The Committee shall be comprised of nine members: the Chairpersons of the four departments; four other faculty members, one from each department elected by the voting faculty members of the respective department; and one at-large faculty member elected by the voting faculty members of the Council.
